## **CURRICULUM DEVELOPMENT/PEDAGOGICAL INNOVATION**

The result was better understanding of the basic language and principles of research.

Following development, I was an active member of the implementation committee. I have been involved in curriculum development from conceptual thinking to implementation and evaluation by outside governing bodies.

I utilized many innovative teaching strategies to improve students' ability to make clinical decisions and think critically. These have included various games in class for review purposes, and case studies for evaluation and discussion (in groups and individually). To simulate more closely the learning and practice of 'real time' nursing, I developed a trauma lab in conjunction with community partners (CFB Shilo). I have also taught in the maternal child area, teaching both clinical and theory courses.

### **KNOWLEDGE TRANSLATION ACTIVITIES**

Many of my activities for dissemination involve Knowledge Translation

Several of my studies have had important implications for practice. The implementation of pain tools study involved RNs as research assistants. This project has resulted in one nurse applying to advance her education, and the group is currently writing a paper for publication about their experience. The group was engaged and excited about the value of research and the potential to impact their practice and experience on nursing practice council.

Other studies will have immediate potential to influence nursing practice – the NREBP study – has shown that providing an EBP course does have an impact on nurses’ attitudes about EBP and use of evidence – the committee is very excited to follow through and plan any changes required in their course.

The continuity of care study will have important implications for the way the care is provided in the community – communication patterns, the way that the confidentiality of health care knowledge should be used to improve care, as well as the way that placements are planned for residents. I facilitated community agencies to discuss the findings at presentations and consider ways to change their practice to provide safer communication about the health needs of people with ID.

The ostomy study has involved RNs providing care across the province and the findings will provide important insights into the development of complications. A side benefit has been that the data base is out of date with many people not accessing service any longer (often deaths) and we are under discussions about ways to improve communication within the health care system to reduce the problems that using an out of date data based creates.

The WCB grant will have important implications for many settings related to work injuries with people with ID as well as other populations displaying challenging or aggressive behaviours. Community presentations in conjunction with St.Amant and WCB conducted in September, 2014. This was followed by Nursing Research Seminar Series by telehealth as there was a waiting list for the community session held at St.Amant. There were also individual program presentations provided to support new conversations about potential changes within programs.

All of these studies are providing valuable insights about theoretical understandings about KT in those settings.
