Through weekly instructor team meetings, we select topics and readings, design lesson plans, and craft exercises and simulations.

I have contributed to the training of graduate students and colleagues by peer reviewing their teaching, serving as a teaching coach and mentor, and sharing course syllabi, assignments, grading rubrics and even Powerpoint slides. Further, I have included undergraduate and graduate students in the research process as active members of research teams and as co-authors. Through their involvement in research design, data gathering and analysis, and knowledge dissemination, students have gained valuable academic training and skills and received professional development mentoring. I have published with several current and former graduate and undergraduate students.
